The Keya Paha County Commissioners met Tuesday, April 9th, 2024, as advertised. Chairman Nilson called the meeting to order at 10:02 a.m. and noted the open meeting's act posted for the public. Present were Commissioners Tuerk and Frederick, and Clerk Wentworth.

After review, Frederick moved to approve the minutes of the previous meeting, Tuerk seconded. Voting: Nilson—yes, Tuerk—yes and Frederick—yes. All voted in favor, motion carried.

Nilson moved to accept the Clerk, Dist. Court Clerk and Treasurers monthly reports, and the Sheriffs quarterly report, Frederick seconded. Voting: Tuerk—yes, Frederick—yes and Nilson—yes, all voted in favor, motion carried.

Amy Johnson met with the commissioners to ask the county to sponsor two dumpsters for the county wide clean-up day that will be held on Saturday May 18th. After discussion Nilson made a motion for the county to pay for two of the dumpsters at the county wide clean-up day, Tuerk seconded. Voting: Frederick—yes, Nilson—yes and Tuerk—yes. All voted in favor, motion carried.

Amy Johnson, representing the Springview Spitfires met with the Commissioners to request using Courthouse Dr. to set up the archway for the color run that will take place May 10th. Nilson moved, Frederick seconded to close Courthouse Dr. on the afternoon May 10th for the color run that the Springview Spitfires are putting on. Voting: Nilson—yes, Tuerk—yes and Frederick—yes, all voted I favor, motion carried.

K. Mizner met with the commissioners to go over his annual reports from the state. There were no deficiencies found. Mizner also presented quotes for a UTV trailer, after review, Nilson moved to purchase a 14ft trailer from Kearney Trailer, Frederick seconded. Voting: Tuerk—yes, Frederick—yes and Nilson—yes. All voted in favor, motion carried.
