The Keya Paha County Commissioners met Tuesday, June 11th 2024 as advertised. Chairman Nilson called the meeting to order at 10:02 a.m. with Commissioners Tuerk and Frederick present along with A. Tiefenthaler and Deputy Clerk Kinney. Nilson made reference to the open meetings act posted for the public.

After review, Frederick moved to approve the previous meeting minutes as presented, Nilson seconded. Voting: Nilson—yes, Tuerk—yes and Frederick—yes, all voted in favor. Motion carried.

Tuerk presented a proposal to commissioners Nilson and Frederick regarding the extension of the down spout on the northeast corner of the courthouse. This item will be further discussed next meeting.

Frederick moved to accept the Clerk, District Court and Treasurers monthly reports, Tuerk seconded. Voting: Tuerk—yes, Frederick—yes and Nilson—yes. All voted in favor, motion carried.

Lee Atteberry came and presented to the Commissioners a proposal on the Richey pit. Discussion was had, Commissioners will discuss further at a later time.

Janitorial agreement was discuss regarding pay. Tuerk made a motion to raise the janitorial agreement to \$1,650 gross pay per month with subject to annual review and documentation, Frederick seconded. Voting: Frederick—yes, Nilson—yes and Tuerk—yes. All voted in favor, motion carried.

L. Smith stopped by to talk with the Commissioners regarding Painter bridge, legals are done and final paperwork is in the process, he will keep them informed on the process.

Commissioners and A. Tiefenthaler went to lunch.

J. Cook, Commissioners and A. Tiefenthaler went and looked at the Painter bridge.

Viaero was contacted with some questions and concerns the Commissioners had regarding the update with the courthouse tower. Further discussion will be happening in the future.
