After, review, Frederick moved to approve the minutes of the previous regular meeting held on July 23rd, 2024, as presented, Tuerk seconded. Voting: Nilson—yes, Tuerk—yes and Frederick—yes. All voted in favor, motion carried. Nilson moved to approve the minutes of the emergency meeting held on July 5th, 2024, as presented, Frederick seconded. Voting: Tuerk—abstain, Frederick—yes and Nilson—yes. Motion carried.

After review, Nilson moved to accept the Clerk, District Court Clerk and Treasurers monthly reports, Tuerk seconded. Voting: Frederick—yes, nilson—yes and Tuerk—yes, all voted in favor. Motion carried.

Under General Business the commissioners went over the exterior painting project at the courthouse that was recently finished. Tuerk moved to approve an additional \$791.35 above the bid for the project of \$2100.00, Nilson seconded. Voting: Nilson—yes, Tuerk—yes and Frederick—yes, all voted in favor. Motion carried. The additional cost is to cover the mortar work that was not included in the original estimate.

The agenda item to approve inventories was tabled until the next regular meeting.

Nilson moved to donate \$200.00 to the Ripley's for the fireworks display over the 4th.

T. Wyrick met with the commissioners to update them emergency management and the ongoing discussion on FEMA projects the county has not been reimbursed for yet. All of the request for information have been filled.

The board reviewed the county audit.

The board discussed bridges that are in need of repairs.

The Commissioners and Tiefenthaler went to lunch.

J. Cook met with the board to update them on road projects and equipment.

After the review of the audit the commissioners drafted a letter to the library board to rectify the auditors' concerns. Tuerk moved to approve the audit and authorize the chairman to sign the required supporting documents, Frederick seconded. Voting: Frederick—yes, Nilson—yes and Tuerk—yes, all voted in favor.
