The Keya Paha County Commissioners met Tuesday, September 10th,2024, as advertised. Chairman Nilson called the meeting to order at 10:05am and noted the open meetings act posted for the public. Commissioners Tuerk and Frederick, Commissioner elect Tiefenthaler, Deputy Sheriff Linse and Clerk Wentworth were present.

After review, Nilson moved, Frederick seconded to approve the minutes as presented. Voting: Nilson yes, Tuerk—abstain and Frederick—yes. Motion carried,

Frederick moved, Nilson seconded to approve the Clerk, Treasurer and District Court Clerks monthly reports. Voting: Tuerk—yes, Frederick—yes and Nilson—yes. All voted in favor, motion carried.

The County received an estimate from the company that inspected the courthouse for the bat infestation. The estimate was \$17,000 to remove the bats, seal all the entry points, disinfect and clean the building with a ten-year guarantee. The commissioners decided to wait and see if the bats continue to be a problem.

Tuerk had been unable to contact a company to estimate the repair where the floor is sagging, there will be an attempt to contact another company.

Deputy Emergency Manager Wyrick met with the commissioners to update them on the latest delay for the 2019 disaster. A new NEMA contact requested more information on the large roads project, Wyrick mentioned to the new contact that the county had signed off on an agreed amount for that project one year ago and was under the impression that the county was just waiting for the funds. Wyrick was told that NEMA contact would look into it, and he hasn't heard back yet.

With the fire on September 5th, and the use of the SEAT plane Wyrick needed an emergency declaration signed by the chairman. Frederick moved, Tuerk seconded to have the chairman sign the Keya Paha County Emergency Declaration. Voting: Frederick—yes, Nilson—yes and Tuerk—yes, all voted in favor. Motion carried.

The Commissioners and Tiefenthaler went to lunch.
