The Keya Paha County Commissioners met Tuesday, December 10th as advertised. Chairman Nilson called the meeting to order at 10:00 a.m. and noted the open meetings act posted for the public. Present were Commissioners Tuerk and Frederick, Commissioner elect Tiefenthaler and Clerk Wentworth.

After review, Frederick moved to approve the minutes of the previous meeting as presented, Nilson seconded. Voting: Nilson—yes, Tuerk—yes and Frederick—yes, all voted in favor. Motion carried.

Nilson moved to accept the monthly reports for Treasurer, Clerk and District Court Clerk, Tuerk seconded. Voting: Tuerk—yes, Frederick—yes and Nilson—yes. All voted in favor, motion carried.

Blair Speck, BKR Extension office met with the commissioners to present an updated BKR Extension Board Constitution and Bylaws. After discussion Frederick moved to accept the amended BKR Extension Board Constitution and Bylaws, Tuerk seconded. Voting: Frederick—yes, Nilson—yes and Tuerk—yes, all voted in favor. Motion carried.

At 10:30 the sealed bids were opened. Nilson made a motion to accept the winning bids on the auto gates as follows: Todd Cook's bids were accepted on the 2 west 12x8 auto gates and Steve Hallock on the east 12x6 auto gate, Frederick seconded. Voting: Nilson—yes, Tuerk—yes and Frederick—yes. All voted in favor, motion carried. Jeff Cook will notify the winning bidders.

The application to occupy the right of way was tabled until more information was received.

T. Wyrick, Deputy EM met with the commissioners to discuss some grant opportunities that would be of benefit to the community and the fire department.

The commissioners took a break for lunch.
