Frederick noted the open meetings act posted for the public and led the pledge of allegiance.

Hamilton, field rep for Nebraska Board of Education Land and Trust, was in attendance stating that he was interested in what the commissioners would do and said that he and D. Painter have talked about

easements, however easements do come with a cost. The commissioners will research to see where the county road ends and get back to D. Painter.

With L. Smith in attendance Commissioner Frederick made a motion that the county does not renew the contract with Lloyd Smith and Niobrara Valley Consultants in 2026 for the Highway Superintendent Position, Tiefenthaler seconded. Voting: Tiefenthaler—yes, Nilson—yes, Frederick—yes. All voted in favor. Motion carried.

2027-2030 Salaries for the Elected Officials were discussed and tabled for the afternoon.

A Painter and T. Wyrick stopped by to give the commissioners an update on FEMA and NEMA payments. The County received payment regarding Wyman's bridge and have been told that another portion has been closed, we will see payment sometime after the first of the year.

Commissioners and E. Scott went to lunch.

J. Cook stopped and gave an update regarding the road department.

After reviewing the audit, Frederick made a motion to approve the 2024-2025 Fiscal Audit report, Nilson seconded. Voting: Nilson—yes, Frederick—yes, Tiefenthaler—yes. All in favor. Motion carried.
